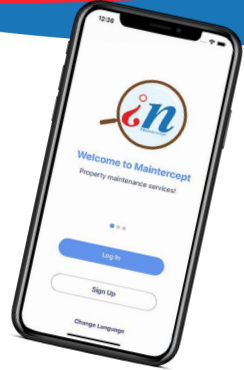

HOW IT WORKS

1

Companies register their employees, i.e., artisans, technicians and engineers, as TSPs on the Maintercept Mobile App.*

2

Employees download Maintercept, register in-App to be TSPs, and follow email instructions to activate their online status.



3

Registration fees are paid as per the attached cost schedule, either individually or by employers for group payments.

4

Employers receive monthly consolidated statements on the job history and revenue generated by TSPs.
